Virtual Capital Hill Day 2021 ASHA Committee of Ambassador for SLP

On March 23, 2021, ASHA Committee of Ambassadors (CoA) met with members of US House of Representatives and the US Senate to discuss three focal issues highlighted by ASHA's 2021 public policy agenda for this year's Virtual Hill Day. This was my inaugural year serving as Wyoming's CoA for speech-language pathology and it was a great experience. I was able to meet virtually with Congresswoman Cheney's staff, Senator Cynthia Lummis, and Senator John Barrasso. The ASHA CoAs were charged with highlighting the following public policies when we met with our state legislators who serve at the national level:

MEDICARE ACCESS TO AUDIOLOGY SERVICES

Medicare only covers diagnostic tests performed by audiologists when ordered by a physician. So, we asked Congress to allow audiologists to provide treatment and diagnostic services for Medicare beneficiaries. We need Congress to improve access to audiology services by recognizing audiologists as independent practitioners who can provide treatment and diagnostic services under Medicare. We are asking Congress to remove the language that lists audiologists as suppliers and change to practitioner.

PROMOTE ACCESS TO EDUCATION SERVICES AND SUPPORTS

States are receiving less than 15% of authorized federal funding for the Individuals with Disabilities Education Act (IDEA) to support children with disabilities. We advocated for change. Increase IDEA funding! We asked Congress to provide additional federal funding needed for states to meet federal mandates for providing services and support for all children with disabilities in the schools.

ENHANCE OLDER ADULT ACCESS TO TELEHEALTH SERVICES

Audiologists & speech-language pathologists are qualified providers of telehealth services. We asked Congress to permanently cover our services for Medicare beneficiaries after the public health emergency. Audiology and speech-language pathology telehealth services are limited during the public health emergency. We're asking for services already covered under Medicare to be added to the telehealth services list during COVID-19.

It was an honor to represent ASHA's public policy during the 2021 Virtual Capital Hill day in order to advocate for the fields of audiology and speech-language pathology. I look forward to continuing these advocacy efforts in the years to come during my term as Wyoming's CoA for speech-language pathology.

Open positions: Wyoming State Board of Examiners of Speech-Language Pathology and Audiology

The Board currently has a vacancy for an Audiologist, Medical Professional and Public Member.

Eligibility:

Board members shall have been residents of this state for at least one (1) year immediately preceding their appointment, and shall have been engaged in rendering services to the public, teaching or research in speech-language pathology or audiology for at least five (5) years immediately preceding their appointment.

All board members except the consumer and licensed health care professional shall at all times be holders of active and valid licenses and be in good standing as a speech-language pathologist or audiologist in this state. The governor may remove any board member as provided in W.S. 9-1-202.

Term Length:

Appointments shall be for three (3) year terms, with no person being eligible to serve more than two (2) full consecutive terms. Terms shall begin on the first day of the calendar year and end on the last day of the calendar year. (d) The board shall meet during each calendar year to select a chairman and vice chairman and for other business. At least one (1) additional meeting shall be held before the end of each calendar year. Further meetings may be convened at the call of the chairman or the written request of any three (3) board members.



Open positions: Wyoming State Board of Examiners of Speech-Language Pathology and Audiology, Continued

Duties:

The board may administer oaths, take affidavits, summon witnesses and take testimony as to matters coming within the scope of its duties. (b) The board shall adopt rules and regulations to implement and enforce the provisions of this act. (c) The board shall utilize an adopted seal to affix to all licenses issued in accordance with this act and to authenticate its proceedings. (d) The board shall administer the Audiology and Speech Language Pathology Interstate Compact in this state as provided in W.S. 33-33-402.

Compensation:

Compensation of board members. Board members shall receive no compensation for their services, but shall receive per diem and mileage as provided in W.S. 33-1-302(a)(vii). (Current Practice Act/Statute)
